## **Retirement Bills Passed**

All four bills which were introduced by the board of trustees have passed both the House and Senate. They have been sent to Governor Rounds for his signature.

### **Bills:**

**SB 18:** An Act to revise certain retirement provisions regarding retired members of the South Dakota Retirement System who return to covered employment and declare an emergency. (Retire/Rehire situation)

**SB 19:** An Act to increase contributions related to the optional spouse protection program with the South Dakota Retirement System and to prohibit any new enrollment in the program. (Spousal Option)

**SB 20:** An Act to revise certain retirement provisions within the South Dakota Retirement System. (COLA) This reduces the annual improvement factor for one year to 2.1% and then thereafter index the COLA to the CPI based on the SDRS funded ratio for future years.

**SB 21:** An Act to revise certain provisions regarding exclusive benefit requirements and the range of investments available to the South Dakota Retirement System member trust fund

The 85th legislative session will be history after March 29th which will be the 38th legislative day. I certainly wish to thank the RTA members for your persistence in contacting legislators and committee members.

Here is some general information about SD Retirement System, the Board of Trustees and the board members.

The South Dakota Board of Trustees is the governing authority with a 17-member board. There are 468 public entities participating in the South Dakota Retirement System. School Districts make up 172 units with 45.5% total active members enrolled. Active members enrolled in SDRS as of June 30, 2009 was 38,596 with about 20,000 members receiving benefits. Of the 17-member board, 14 are elected, 2 are governor's appointees, one is an Ex Officio non-voting member from the SD Investment Council. Sylvia Henkin was president of Junior Achievement, Sioux Empire United Way, Community Playhouse, Karl E. Mundt Historic Foundation and other organizations. Although she's not Irish, Sylvia has organized the St. Patrick's Day parade for 19 years.

Both Timm and Henkin live in Sioux Falls. They will have their books for sale at the convention.

Some interesting historical South Dakotans will also make appearances on Tuesday. Among them will be H. H. Beadle, John Banvard, J.L.W. Zietlow, Sitting Bull, Frank Leahy and some homesteaders' wives. After dinner Scotty Philips and Jim Taggart will show up. We can learn about John McCandish King and Peter Norbeck through visual presentations. Unit leaders will explain the background of their towns' names during the "Municipal Moments" scattered throughout the convention time.

Aren't you eager to get an update on the retirement system? On Wednesday morning, after the memorial service and business meeting, Wyland Borth, Dr. Jim Hansen and Rob Wylie will tell about legislative action which affects the system and our pocketbooks. AARP will be represented at the convention and also provide breakfast and refreshments – thank you! The business meeting, conducted by President W. Allen Price, will include voting on new officers and bylaws changes.

Who will the 2010 Grandparent Essay Contest winner be? It is always a joy to hear a 5th grader read the winning essay, and hopefully, the grandparent can share the stage with him/her. Who will be awarded the Florence Krieger Award? And might you be lucky enough to win a door prize?



## Alert - Alert - Alert

Beginning March 1, 2010, the State of South Dakota will be participating in a Federal energy efficient appliance rebate program. The State will have \$738,391 to distribute to eligible applicants for the purchase of new appliances to replace less-efficient appliances. This will be done on first come, first served basis. The rebates will be handled by the State of South Dakota and will take 6 - 8 weeks to receive the rebate. The following information is provided so that you can get the details of the program.

Starting March 1, 2010, rebates will be available for the purchase of certain ENERGY STAR® qualified appliances that will replace existing appliances. The appliances and rebate levels are:

- Clothes washers: \$100 • Dishwashers: \$75
- Refrigerators: \$150 • Freezers: \$150
- Water Heaters: \$125

The rebates will be available on a first come, first served basis subject to availability of the limited funds. The amount of rebate funds available will be regularly updated on the website.

Appliances purchased before the March 1 program start date are NOT eligible for rebate. Please read the eligibility requirements before making your purchase.

# SDRTA Trip to Eastern Iowa October 3rd - 9th, 2010



If you are planning some autumn adventures before facing another SD winter, why not join SDRTA members and friends for a week of fun-filled activities in Iowa Oct. 3-9, 2010? We plan to experience a wonderful mix of history and modern innovations as we spend two nights in Cedar Rapids, three nights in Dubuque, and one night in Mason City. A day at the Amana Colonies will help us understand their lifestyle since the 1850's. Another day trip will take us to Galena, IL. to enjoy their small town charm and beauty.

The Cedar Rapids area was home to artist Grant Wood, and we plan to learn more about his work. Dubuque has the National Mississippi River Museum and Aquarium which is Iowa's number one attraction. They also have historic homes, Tiffany stained glass windows, and casinos. Mason City has the Music Man Square and childhood home of Meredith Willson. In contrast, nearby Clear Lake features the Surf Ballroom where Buddy Holly performed his last concert in 1959. These will be some of our visits. Trust us to find other Iowa treasures for you.

This trip will also offer an unscheduled evening in Dubuque without a group meal or activity. We will offer an optional visit to four Victorian mansions to enjoy a special five-course progressive dinner with entertainment. The cost for this is \$50 per person so we offer it as an option for those that are interested. You can choose this option or enjoy a free evening in this oldest city in Iowa.

This SDRTA Fall tour departs at 12:00 pm from **Sioux Falls Sunday, October 3, 2010** and will return early afternoon on Saturday, October 9<sup>th</sup>. Due to the sale of the Foreman Charter service to Harms Oil of Brookings, there is no longer a charter bus available from Miller. Therefore it is cost prohibitive to have a bus from Sioux Falls travel to Pierre as a pickup point. Cost per person is \$730 based on double occupancy with a \$20 discount for SDRTA members. This includes transportation, 6 nights lodging, 6 breakfasts, 5 dinners & 5 lunches, all admissions, taxes, and fees. An itinerary will be sent to participants in early September.

We must have at least 35 participants to make this trip feasible and the tour will be capped at 50. To determine the winner of the traveling trophy, it will be based on two criteria.

1) We will take the number of members attending the convention and divide that number by the number of total members.

2) We will figure the number of miles traveled, plus 1% additional for each 10 miles traveled.

Example: Unit A has 8 out of 42 members attending.

$8/42$  or 19.04%

Unit A traveled 253 miles which is 25.3%.

Add 19.04 and 25.30 = 44.34%

Unit B has 4 out of 31 members attending.

$4/31$  or 12.96%

Unit B traveled 220 miles which is 22%.

Add 12.96 and 22.00 = 34.96%

**Unit A is the winner!**
